# REPORT ON THE PURCHASE OF TREASURY SHARES

Milan, 02 March 2018 – During the period from 19 February to 02 March 2018, **Alkemy S.p.A.** – leading company in the innovation of the business model of large and medium-sized companies and listed on the AIM Italia market of Borsa Italiana from December 5<sup>th</sup> 2017 (ticker: ALK) – acquired no. 9.000 treasury shares for a total consideration of 113.620,08 Euros, as authorized by the Board of Directors meeting on 19 February 2018, and then disclosed pursuant to Art. 144-bis of Consob Regulation no. 11971/1999.
