REPORT ON THE PURCHASE OF TREASURY SHARES

Milan, July 27th 2018 – During the period from July 23th to July 27th 2018, **Alkemy S.p.A.** – leading company in the innovation of the business model of large and medium-sized companies and listed on the AIM Italia market of Borsa Italiana from December 5th 2017 (ticker: ALK) – acquired no. 3.000 treasury shares for a total consideration of 36.652,02 Euros, as authorized by the Board of Directors meeting on 30 May 2018, and then disclosed pursuant to Art. 144-bis of Consob Regulation no. 11971/1999.

Following the above purchases, considering also the treasury stock already in portfolio (relating to purchases of the first Buyback Program) amounting to 26,062 shares, after having spent 57.062 treasury shares as partial payment for the purchase of 51% of the capital of Ontwice Interactive Service S.l., Alkemy S.p.A. holds no. 4.600 treasury shares as of July 27th 2018, equal to 0.084% of the issued share capital.
